### Worldox® Upholds Winning Track Record, Besting Legal DMS Competition in 2010 Law Technology News Technology Vendor Satisfaction Survey Results

Also, Worldox/Web Mobile attained top marks in the Mobile Tools/Devices/Services category.

According to the Survey, notable wins for Worldox where the software performed markedly higher than competitors (in some cases 30% higher) were in the areas of Brand Reputation (98.1%), Ease of Integration into Firm's Workflow (92.6%), Features and Functions (90.7%) and Price for Value (87%).
